7. Canal Case #15-2016 – Bayside Marine on behalf of Joe Ventimiglia – 22452 Maple – Install 126' of new steel seawall within one foot of old wood seawall. Backfill from upland source. No rip rap will be used because it would fill in canal.
8. Canal Case #16-2016 – Marine One on behalf of Donald Smolenski – 22557 Milner - Install 186' of new steel seawall with 7.5' return wall. Excavate 40 x 16 boat well. Install 4 post boat lift inside new boat well. Install 11 spring piles.
9. Canal Case #17-2016 – Marshall Marine on behalf of Jeff Geise – 22540 Ardmore - Install 46' of steel seawall in front of existing seawall.

10. Canal Case #18-2016 – Marshall Marine on behalf of Edna Jeyes – 22581  
Ardmore - Install 74' of steel seawall directly in front of existing seawall. Remove and re-install 6 wood pilings.
11. Any other business that may properly come before the Board.
