We make nine trips on **Friday** (weather permitting) to Mt. Holly starting mid December through the end of February.


Buses leave the Civic Arena parking lot at 4pm and return at Midnight.



**SKI AND SNOWBOARD CLUB
RULES AND REGULATIONS**

The following Rules and Regulations shall apply to any and all St. Clair Shores Ski and Snowboard Club members.

1. A skier must abide by the patch system as to the level of his/her skiing ability determined by the ski instructor. Thereafter, the student must purchase the particular ski mountain patch where available at the ski site and wear such patch on the outer left sleeve. The student must only ski on the patch designated slopes.
2. The St. Clair Shores Ski Club patch must also be worn on the outer left sleeve of each skier.
3. A member must carry on his person at all times the student identification card devised by the St. Clair Shores Ski and Snowboard Club or by the skiing facility. If the card is lost, the member must purchase a new one immediately.
4. A member's student identification will generally be good for discount rates on any additional non-ski club nights, subject to the regulation of the particular skiing facility.
5. All new members, all members renewing memberships and all beginning skiers are required to take two ski instruction lessons per season. Additional lesson tickets will be available from supervisors.
6. Members are responsible for protecting their own ski equipment and either locking it with a ski lock or checking it at a ski corral.
7. A member's long hair must be tied back or inside a hat so as to prevent injury.
8. The wearing of long scarves and hats with tassels is prohibited.
9. Members are responsible for bringing their own lunches or appropriate meals or purchasing same at the ski facility or event.
10. The St. Clair Shores Department of Parks & Recreation, the City of St. Clair Shores, and any part-time or full-time personnel thereof or any other volunteer, employee, servant, representative or supervisor shall not be responsible for any sickness, illness, personal injury or property damage arising out of or related to in any way a members participation in the Ski Club or a Ski Club event of any kind. Should an injury arise, Ski Club representatives will make every effort to contact the member's parents immediately.
11. Members should check with their schools to determine the possibility of their schools allowing storage of skis during the school day prior to an event.
12. Members must turn in rental skis by 10:00 p.m. or as may be required at a particular event.
13. Members must leave the ski slopes by 10:00 p.m. or as designated at the particular site or event.

14. Members must board the club bus not later than 10:30 p.m. for the return trip or at such a time as designated by a club supervisor for the particular event. A member **MUST** return on the same bus that he/she traveled on to the destination.
15. Members must remain in their seats and are not permitted to smoke.
16. Consumption of alcoholic beverages, use of drugs, use of cigarettes, and any misbehavior is strictly prohibited.
17. No glass containers, no thermos bottle, or any other kind of container shall be permitted or transported to any ski club event. Soda/Pop may be taken, but must be unopened cans while on the bus or other mode of transportation.
18. Club supervisors have absolute control and authority over each individual member or group of members on the bus and off.
19. Members must submit to the search of their person, equipment and bag in the event two or more supervisors agree that such a search is necessary.
20. When boarding a club bus, members with their own skis should carry them with the ski tips up. Club assistants will then collect money and hand out lift tickets for lift fees and rentals. All members must have EXACT cash or checks for such expenses. If checks are submitted, they must be made out to the appropriate facility, **NOT** the Ski Club.
21. On regular ski trips and the weather is questionable, parents are encouraged to call the Recreation Department **AFTER** 12:00 noon, this gives us time to check on the condition of the slopes.
22. On regular weekday ski trips, the club bus pick-up will be at the Civic Arena at about 3:30 p.m. after school. On regular weekday ski trips, the club bus will return at approximately midnight to the Civic Arena. Parents must arrange for student transportation home. **FAILURE TO PICK-UP A MEMBER ON TIME MAY RESULT IN SUSPENSION OF THE MEMBER.**
23. In the event of a rule violation or other problem arises with a particular member, the Coordinator of the Ski and Snowboard Club and Director of Parks and Recreation have the discretion to impose any or all of the following penalties:
 - a) Issuance of warning.
 - b) Notification of parents.
 - c) Suspension from all club activities for one week or longer with no refunds.
 - d) Termination from the club with no refund.

AUTHORIZATION/CONSENT FOR TREATMENT OF MINOR

I (we), the undersigned, parent(s)/legal guardian(s) of the above-named minor, do hereby consent that an ADULT JUNIOR SKI CLUB REPRESENTATIVE, at his/her sole discretion, may authorize any care, including diagnostic procedures and medical treatment as may be in his/her judgment deemed necessary or beneficial for said minor. Such authorization shall include, but not be limited to, any x-ray examination, anesthetic, medical or surgical diagnosis or treatment, and hospital service. Further, such representative shall have the authorization to select the medical facility, including a hospital or medical-related clinic or doctor's office or similar location, where such treatment or other medical activity is to take place. It is understood that this consent is given in advance of any specific diagnosis or treatment being required, and is intended to encourage a physician and all medical personnel to exercise their best judgment with regard to any such diagnosis and treatment.

This consent/authorization shall be effective whenever said minor is in the care, custody, and/or control of the Ski Club and/or is participating in any St. Clair Shores Department of Parks and Recreation and Ski Club sponsored event, trip or activity in which the undersigned is not present. Further, this consent/authorization shall remain effective unless the undersigned has revoked it in writing and delivered it to the City of St. Clair Shores, Department of Parks & Recreation, 20000 Stephens Drive, St. Clair Shores, Michigan 48080. No changes, additions, or deletions shall be made to this form or shall be deemed acceptable as varying any terms of the consent/authorization.

RELEASE OF RESPONSIBILITY/HOLD HARMLESS

I (we), the undersigned, as the minor/member, and as parents or legal guardians acting on behalf of ourselves and the minor's parents, do hereby acknowledge that I (we) and our member/participating child(ren)/ward(s) have and are assuming all risk of any kind associated with Ski Club participation and membership including but not limited to, transportation to and from any club events, all skiing and ski instruction, personal injury and property damage, the propriety of medically-oriented decision-making and treatment or the lack thereof, etc. As such, I (we), the undersigned, as the Ski Club member or the minor/member, and as parents or legal guardians acting on behalf of ourselves and the minor's parents, do hereby release and hold harmless from all liability of any kind the City of St. Clair Shores and the Ski Club as well as their families. Such release/hold harmless shall extend to and include, but not be limited to, the following examples of claims and liability: any loss, damage and/or injury, whether to person or property, arising out of or related in any way to a member's participation or presence at a Ski Club or St. Clair Shores sponsored event, activity or trip, and to the propriety of decision-making for medical treatment or lack of medical treatment that such a minor may or may not have received at the discretion of an adult Ski Club representative.

1. Have completed the above with true and accurate information.
2. Have read and do understand and agree to be bound by the contents and provisions of the "Authorization/Consent for Treatment of Minor" and "Release of Responsibility/Hold Harmless" paragraphs
3. Agree to allow the above-named minor and/or his/her luggage or equipment to be searched at any time the supervisors (two or more) may deem it necessary.
4. Agree to assume full responsibility for damage to and/or loss or expense of any rental equipment which the participant rented from any facility.
5. Have read the SKI CLUB RULES AND REGULATIONS and agree to be bound by such terms and provisions as they may be amended from time to time.
